

TOWN OF TRENTON  
REGULAR BOARD MEETING  
JUNE 16, 2025

Meeting was called to order at 7:00 p.m. by Chairman Russell Kottke.

**Attendance:** Karla Zimmerman, Russell Kottke, Melissa Pausma, Kristie Buwalda, Jeff Wilson, Karen Callies, and Earl & Kelly Braker

**Minutes** were read by Karla. Motion by Kristie, 2<sup>nd</sup> by Jeff, to approve the minutes as read. Motion carried.

**Treasurer Report** was read by Melissa. Balance on hand \$5,836.56 in the checking account. Motion made by Kristie, supported by Jeff. Motion carried.

**Letter of Intent** for Ruben Neumann for a minor land division. Karen Callies expressed plans to divide 5 acres from the house and buildings for a future home project or small farm.

**Citizen Comments:** Earl Braker expressed his annoyance for the lack of lawn care by his neighbor. The Town of Trenton and Dodge County do not have ordinances in place for lawn care. WI State Statute 66.0407 does require landowners to destroy noxious weeds that are on their property. Karla will draft a letter to the landowner addressing the violation with a request for prompt action.

Earl also expressed concern over the approval of the Conditional Use Permit for RNC Properties that was approved by the town at the May meeting and subsequently approved by Dodge County. He is an adjoining landowner, and he feels it pushes the limits of small business. He has concerns over the potential compost piles and smell, truck traffic, noise and dust being so close to his home.

**Liquor License applications** were presented for The Wood Hill & Cantafios Buckhorn. Kristie made a motion to approve, Jeff 2<sup>nd</sup>, Motion carried.

**Temporary Picnic License** application for Waupun FFA Alumni was presented for the Blue & Gold Banquet scheduled for October 11, 2025. Kristie made a motion to approve, Jeff 2<sup>nd</sup>, Motion carried.

**Bartender License** applications for Wanda Van Buren, Jesse Parenteau, Kevin Homan, Andrea Homan, Cassandra Douma, Briann Winning, Dawn Purser, Kari Pargeter, and Bobbie Cantafio were presented. Kristie made a motion to approve, Jeff 2<sup>nd</sup>, Motion carried.

**Road Report:** Russell reported that the road work is completed but that culvert work needs to happen yet.

Breezy Point Road also has a flooding situation caused by a berm placed in the right-of-way by the landowner. Russell will talk to them about a solution.
